# PLANNING & ZONING

Mr. Walbert introduced the Public Hearing for the International Fire Code Zoning Ordinance.

AN ORDINANCE OF THE BOARD OF SUPERVIOSRS OF THE TOWNSHIP OF HANOVER, NORTHAMPTON COUNTY, COMMONWEALTH OF PENNSYLVANIA AMENDING ORDINANCE 02-01, CHAPTER 53, THE 2001 HANOVER TOWNSHIP BUILDING CODE, BY ADOPTING THE 2006 EDITION OF THE INTERNATIONAL FIRE CODE AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES INCONSISTENT HEREWITH

# **ADMINISTRATION**

Mr. Nagle moved that the Board approve the following Ordinance, International Property Maintenance Code Ordinance, which adopts the 2006 Edition of the International Property Maintenance Code--regulating and governing the conditions and maintenance of all property, buildings and structures; by providing the standards for supplied utilities and facilities and other physical things and conditions essential to ensure that structures are safe, sanitary and fit for occupation and use; and the condemnation of buildings and structures unfit for human occupancy and use, and the demolition of such existing structures in Hanover Township; providing for the issuance of permits and collection of fees.

#### **ORDINANCE NO. 09-18**

AN ORDINANCE ENACTED BY THE BOARD OF SUPERVISORS
OF HANOVER TOWNSHIP, NORTHAMPTON COUNTY, PENNSYLVANIA,
ADOPTING THE "2006 EDITION OF THE INTERNATIONAL PROPERTY
MAINTENANCE CODE", REGULATING AND GOVERNING THE CONDITIONS
AND MAINTENANCE OF ALL PROPERTY, BUILDINGS AND STRUCTURES; BY
PROVIDING THE STANDARDS FOR SUPPLIED UTILITIES AND FACILITIES AND
OTHER PHYSICAL THINGS AND CONDITIONS ESSENTIAL TO ENSURE THAT
STRUCTURES ARE SAFE, SANITARY AND FIT FOR OCCUPATION AND USE; AND
THE CONDEMNATION OF BUILDINGS AND STRUCTURES UNFIT FOR HUMAN
OCCUPANCY AND USE, AND THE DEMOLITION OF SUCH EXISTING
STRUCTURES IN HANOVER TOWNSHIP; PROVIDING FOR THE ISSUANCE OF
PERMITS AND COLLECTION OF FEES THEREFORE; REPEALING ALL OTHER
ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT THEREWITH.

- Mr. Salvesen seconded the motion.
- Mr. Salvesen questioned Section 307.2.3 and suggested a change.
- Mr. Finnigan stated there are certain parts that can be modified by the municipality and believes that this is a section that the municipality cannot change. There are two other factors in regards to the time period; which are the NPDES Permit and Erosion Sedimentation and Control approvals from the County; and the time period is determined by the zoning officer.
- Mr. Salvesen questioned if this sets any objective criteria for public lighting, specifically the depths of the cables.
- Mr. Milot stated he is not aware of any specifics of that nature; this is more of a nuisance type ordinance.
- Mr. Broughal stated that the Board has already adopted the 2003 Property Maintenance Code.
