# Policy 43-20 Preschool Fees & Tuition Policy

It shall be the policy of the Board of Supervisors, Hanover Township – Northampton County to establish Preschool Fees and Tuition policy. Policy effective January 1, 2010 is as follows:

- Preschool Application Fee is due in January \$60.00. Fee is non-refundable and entitles student to a basic membership at the Center.
- A 30% Tuition Deposit is due on June 15<sup>th</sup>.
- Monthly installments start August 15<sup>th</sup> for 5 months (August, September, October, November & December). Tuition to be paid in full by December 15<sup>th</sup>.
- 5% Discount on Tuition if paid in full by September 1<sup>st</sup>.
- When paying monthly a \$25 late fee is applicable if not received within 10 days of due date. This applies to all payments including tuition deposit.
- If deposit is not received by June 15<sup>th</sup>, spot will be given to the next person on the waiting list.

# KSB Holdings – 310 Stoke Park Road – Site Plan Improvements, Site Plan Maintenance and Declaration Agreements for Signature

# ORDINANCE NO. 09-\_\_\_\_

AN ORDINANCE ENACTED BY THE BOARD OF SUPERVISORS OF HANOVER TOWNSHIP, NORTHAMPTON COUNTY, PENNSYLVANIA, ENACTING RESTRICTIONS ON THE USE OF BRAKE RETARDERS ON CERTAIN ROADS WITHIN THE TOWNSHIP AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES INCONSISTENT HEREWITH NOW, THEREFORE, be it enacted and ordained by the Board of Supervisors of Hanover Township, Northampton County, Pennsylvania, and the same is hereby ordained and enacted as follows, to wit:

<u>SECTION 1</u>. The Supervisors of Hanover Township, Northampton County, Pennsylvania, under the powers vested in them by the "Second Class Township Code" and the "Pennsylvania Motor Vehicle Code," as amended, as well as other laws of the Commonwealth of Pennsylvania, do hereby ordain and enact the following amendment to Ordinance 09-01, Article III, Chapter 172.

<u>SECTION 2</u>. Pursuant to the Pennsylvania Motor Vehicle Code and the regulations of the Pennsylvania Department of Transportation, Hanover Township obtained traffic and engineering studies from Hanover Engineering Associates, Inc. dated July 1, 2002, November 10, 2008, July 14, 2008 and February 26, 2007 which traffic and engineering studies support the restrictions on brake retarders as hereinafter set forth.

SECTION 3. Ordinance 09-01, Article III, Chapter 172, Section 172-37 of Hanover

Township is hereby amended as follows:

"§172-37C. No person shall operate and no owner shall permit the use of Brake Retarders on any motor vehicle on the following Hanover Townships streets:

- (1) Hanoverville Road (SR 3014) between PA Route 512 and the East Allen Township Line (traffic & engineering study dated November 10, 2008);
- (2) Hanoverville Road (T-437) between dead end and Township Line Road within Hanover Township limits (traffic & engineering study dated February 26, 2007);
- (3) Southland Drive (T-743) between S.R. 512 and North Commerce Way (T-765) (traffic & engineering study dated February 26, 2007);
- (4) North Commerce Way (T-765) between Southland Drive (T-743) and Hanoverville Road (S.R. 3014 §T-437) (traffic & engineering study dated February 26, 2007);
- (5) Jaindl Boulevard between Township Line Road and PA

State Route 512 (traffic & engineering study dated July 14 2008); and

- (6) Sterner's Way between PA Route 512 and Jaindl Boulevard (traffic & engineering study dated July 14, 2008).
- (7) PA State Route 512 between Highland Avenue (T453) / Stoke Park Road (T433) north to the East Allen Township Line (traffic & engineering study dated July 1, 2002).

SECTION 4. If any section, clause, provision or portion of this Ordinance or

regulation incorporated herein shall be held to be invalid or unconstitutional by any court of

competent jurisdiction, such decision shall not affect any other section, clause, provision or portion

of this Ordinance or regulation.

SECTION 5. All Ordinances and parts of Ordinances inconsistent herewith be and

the same are hereby repealed.

## Northgate I Lot Consolidation and Land Development Plan Extension

Mr. Tanczos moved that the Board approve to grant Northgate I Development for the Lot Consolidation and Land Development Plan an extension of nine (9) months to August 4, 2010 and to notify the Developer of the Board's action.

Mr. Salvesen seconded the motion.

Upon clarification from Mr. Birdsall and a recommendation by Mr. Broughal, Mr. Tanczos amended his motion to read "that the Board approve to grant Northgate I Development for the Lot Consolidation Plan an extension of nine (9) months to August 4, 2010 and to notify the Developer of the Board's action".

# Northgate II Lot 3 Status Report and Request for Verification of Security – Letter of Credit

Mr. Tanczos noted for the record that the Township has not received any notice that Letter of Credit No. 132225541 with Univest National Bank and Trust for Northgate II Lot 3 will not be extended, and therefore, automatically extended on a month to month basis.

# LVIP IV Lot 12 Status Report and Request for Verification of Security – Letter of Credit

Mr. Tanczos noted for the record that the Township has not received any notice that Letter of Credit No. EB-1302008P with Embassy Bank for LVIP IV Lot 12, Polaris Dozen, will not be extended. The Board previously granted the Developer an extension for completion of the development to June 29, 2010 upon certain conditions. The Township Engineer will notify the Developer requesting they provide an immediate response to the conditions that were not met.

# PNC Bank Status Report and Request for Verification of Security – Letter of Credit

Mr. Birdsall stated that he has sent a letter to PNC Bank reminding them of the problems that need to be corrected and to post their security for maintenance.

# Status of Generator Transfer Switch at Jacksonville Road and Orchard Lane/Crawford Drive Jaindl Project.

Mr. Birdsall reported that the work is not done and he has not heard back as to when the work is expected to be completed. Mr. Walbert requested Mr. Birdsall get a commitment as to when the work will be done.

Ryan Conrad, Government Affairs Director for the Lehigh Valley Association of Realtors, thanked the Board for postponing the Resale Certificate of Occupancy Ordinance for further review.

## STAFF REPORTS

Mr. Birdsall reported that the Northeast PA Lions Eye Bank have met all conditions and was approved to go into maintenance in September. After a discussion regarding the Davis Subdivision, Mr. Walbert requested that this item be placed on the next meeting's agenda.

Mr. Broughal had nothing to report.

Mr. Finnigan stated that leaf pick up has begun and residents can check the website for updates on starting locations.

Mr. Finnigan provided copies of the Fire Company's monthly report and 2010 Budget to the Board.

Mr. Finnigan also updated the Board with personnel changes regarding the hiring of the staff person – Jodi DeLeonardo to fill the office opening and the resignation of Susan Lavelle, Director of Children's Services at the Community Center.
