Mr. Diacogiannis requested Mr. Finnigan notify Hindu Temple regarding a request for maintenance inspection.

Minrad, Inc. WIP Tank Farm Site Plan Preliminary/Record Approval

Mr. Tanczos moved that the Board approve the Preliminary/Record Site Plan for LVIP IV Lot 45 Minrad, Inc. – WIP Tank Farm Addition upon the following conditions:

CONDITIONS

- 1. The Developer/Owner shall enter into a Covenant running with the land shall include provisions satisfactory to the Township Solicitor, that the stormwater collection, conveyance and control facilities located on private property shall be properly operated and maintained. (Stormwater Section 152-10M).
- 2. The Developer/Owner shall pay all current fees, including any outstanding plans and appeals account charges. (SALDO Section 159-36J).
- 3. The Developer/Owner shall provide two (2) Mylars for recording the plans and ten (10) sets of plans which are signed and notarized by the Owner and sealed by the Engineer. (SALDO Section 159-34B).
- 4. The Developer/Owner shall meet all conditions of the Preliminary/Record Plan approval, and the Record Plan shall be recorded within twelve (12) months of Conditional Plan approval, and agrees that if such conditions are not met, the conditional Preliminary/Record Plan approval shall be considered void, and the application for Preliminary/Record Plan approval shall be considered void and withdrawn.

Mr. Tanczos further moved that the granting of conditional approval of this plan recognizes that the Township is agreeing to the following on the Site Development Plan:

- A. That the Board of Supervisors waive the requirement of submitting Land Development Plan as allow the proposed project to continue under the Site Plan process. (Zoning Ordinance Section 185-22C.).
- B. That the Board of Supervisors waive the requirement that a Soil Erosion and Sedimentation Control Facilities Plan and Narrative is required for Township review and allow the facilities to be shown on the Site Plan. (Zoning Ordinance Section 159-29E.(6)).
- C. That the Board of Supervisors waive the requirement that acknowledgement of review by the Lehigh Valley Planning Commission is required along with a signature block. (Zoning Ordinance Sections 159-29F.(4)/159-30B.(F)).
- D. That the Board of Supervisors waive the requirement of supplying an Improvements Agreement and security, since it will not impact any existing public improvements. (Zoning Ordinance Section 159-30D.(5)).

- E. That the Board of Supervisors waive the requirement of supplying a Maintenance Agreement and security, since it will not impact any existing public improvements. (Zoning Ordinance Section 159-30D.(6)).
- F. That the Board of Supervisors waive the requirements of submitting additional storm water design and allow previously submitted calculations to satisfy the requirement. (Chapter 152-Stormwater Management).

Mr. Tanczos further moved that the Township Secretary be authorized to notify the Developer of the Board's action.

Mr. Nagle seconded the motion.

Mr. Christian M. Perrucci, Esquire representing Piramal Healthcare Limited, formerly Minrad, addressed the Board. He explained that the new management is now in place and they currently have 80 employees. Mr. Perrucci thanked the Board for their approval of the tank farm and answered questions from the Board. It is noted for the record that the Conditions document was signed by Mr. Michael Tomaine, Piramal Healthcare Limited Engineering Manager and submitted to the Board.

Infrasource Presentation

Mr. Jeff Sergent of Gwin Dobson & Foreman Inc. on behalf of Northeastern ITS explained the upcoming Fiber Optic Cable construction project in Hanover Township and that he is the point of contact for any questions the Township may have. He anticipates starting in May and construction will take approximately 3 weeks to complete. Mr. Salvesen asked if there will be any settlement and Mr. Sergent explained that the line started in Chicago and was completed over a year ago and settlement has not been an issue. He stated that if the Township would like, an insurance restoration bond can be done. Mr. Sergent will email Mr. Finnigan a blanket form he has used in the past.
