RESOLUTION 2010-08 HANOVER TOWNSHIP – NORTHAMPTON COUNTY

WHEREAS, the Board of Supervisors of Hanover Township, Northampton County, Pennsylvania ("Applicant") desires to undertake the following project: Hanoverville Road Park; and

WHEREAS, the applicant desires to receive from the department of Conservation and Natural resources ("Department") a grant for the purpose of carrying out this project; and

WHEREAS, the application package includes a document entitled "Terms and Conditions of Grant," and a document entitled "Grant Agreement Signature Page"; and

WHEREAS, the applicant understands that the contents of the document entitled "Terms and Conditions of Grant" including appendices referred to therein, will become the terms and conditions of a Grant Agreement between the applicant and the Department if the applicant is awarded a grant, and

NOW THEREFORE, IT IS RESOLVED THAT:

- 1. The "Grant Agreement Signature Page" may be signed on behalf of the applicant by the Official who, at the time of signing, has TITLE of Vice Chairman of the Board of Supervisors.
- 2. If this Official signed the "Grant Agreement Signature Page" prior to the passage of this Resolution, this grant of authority applies retroactively to the date of signing.
- 3. If the applicant is awarded the grant, the "Grant Agreement Signature Page", signed by the above Official, will become the applicant/grantee's executed signature page for the Grant Agreement, and the applicant/grantee will be bound by the Grant Agreement.
- 4. Any amendment to the Grant Agreement may be signed on behalf of the grantee by the Official who, at the time of signing the amendment, has the **TITLE** specified in paragraph 1 and the grantee will be bound by the amendment.

Award Bid for the New Server / Computer Hardware Project

Airport Commons – Update

He explained that they continue to market office space however there has been very little interest most probably due to current economic conditions. Mr. Birdsall suggested they ask for an extension to the improvement agreement, which will expire April 30, 2010 and recommend they come up with a plan and commitment to stabilize the property within the next month.

Mr. Walbert informed Mr. Laskowski that a formal request needs to be made for the extension by the April 27, 2010 Board of Supervisors meeting and that any outstanding Plans & Appeals bills must be paid. Ms. Stranzl will advise if there are any outstanding bills.

LVIP IV Lots 38/39 Myers Power Products, Inc. – Improvement Status

Mr. Tanczos moved that the Board, as recommended by the Township Engineer's letter dated April 6, 2010 that the Township accepts the improvements as complete for the LVIP IV – Lot 38/39, Myers Power Products Development Plan, authorize the start of the eighteen (18) month Maintenance Period, effective April 13, 2010, and to return the balance of the Improvements Bond on the following conditions:

- 1. That the Developer provide Maintenance Security in the amount of \$79,005.00 prior to April 20, 2010.
