REGULAR SEMI-MONTHLY MEETING May 11, 2010

PLANNING & ZONING

Public Hearing - Conditional Use Application—St. Luke's Hospital - Research Laboratory - 77 S. Commerce Way

Mr. Walbert closed the regular meeting and opened the Public Hearing. It is noted for the record that the hearing had been duly advertised and the Secretary has proof of publication. A Court Stenographer was present to record all testimony.

Upon completion of testimony, Mr. Walbert closed the Public Hearing and re-opened the regular meeting.

Conditional Use Application Approval – Venel Institute, Post Secondary School for Medical and Surgical Training – 261 Brodhead Road

Mr. Walbert moved that the Board approve the Conditional Use Application for Venel Institute, Post Secondary School for Medical and Surgical Training located at 261 Brodhead Road on the following conditions:

- (1) The Applicant's facility must be subject to Real Estate Tax pursuant to 53 P.S. §68205(a), *et seq*.
- (2) The Applicant shall provide, within thirty (30) days of execution, a copy of the lease for the facility indicating that landlord agrees that the building in which the Applicant's facility is located will not contain a research laboratory or other similar type facility as long as Applicant is a tenant.
- (3) The Applicant shall not discharge any waste other than normal domestic sewage into Township's sewage disposal system.
- (4) The Applicant shall install eleven (11) additional parking spaces at the discretion of the Township.
- (5) The Applicant agrees that a qualified staff person of the Applicant will be present at Applicant's facility at all times that it is occupied.

BASD – Proposed Solar Panels – Asa Packer and Hanover Elementary Schools

Mr. Terry P. DeGroot, P.E. and Mr. Arif Fazil, P.E. of Terraform Engineering, LLC presented site plans for proposed photovoltaic solar panels at Asa Packer and Hanover Elementary Schools for exclusive use by the schools. In order to move forward with the grant process, Mr. DeGroot requested a letter from the Board stating that the panels are a permitted use

in the Township. Letters were obtained from Bethlehem Township, the Borough of Freemansburg and the City of Bethlehem. Mr. Diacogiannis requested the Solicitor's and Engineer's guidance in crafting a letter by the next Board of Supervisors meeting.

Mr. Finnigan distributed the Fireman's Relief Association's end of year financial report.

Mr. Finnigan and Ms. Stranzl met with Brown & Brown regarding insurance policy renewals.
