PLANNING & ZONING

Conditional Use Approval – Moravian Development Corp., for 3925 Airport Road

Mr. Walbert moved that the Conditional Use Petition of Moravian Development Corporation dated May 24, 2010, for which a Public Hearing was conducted before the Board of Supervisors of Hanover Township on June 22, 2010, and which proposes a group home to occupy a single family residential dwelling located at 3925 Airport Road, Hanover Township, Northampton County, is hereby granted subject to the following conditions:

- 1. There shall be no more than six (6) residents not including supervising personnel at any one time in the Group Home.
- 2. There shall be twenty-four (24) hour on-site supervision by people qualified by training and experience in the field for which the Group Home is operated.
- 3. Any medical or counseling services shall only be provided to residents of the Group Home.
- 4. The Group Home shall at all times be classified by the state and county agencies as a housing program and not a treatment program.
- 5. The Group Home activity shall not be related to criminal rehabilitation of either juveniles or adults nor the criminally insane nor serious alcohol or drug addiction, nor the care or housing of any persons prone to violence.
- 6. The Group Home shall register on an annual basis by January 15th of each year its location, number of residents, operating agency and supervising agency with the Township and such information shall be available to the public.
- 7. No resident of the Group Home shall operate, park or store a motor vehicle at the Group Home.
- 8. The operator of the Group Home shall provide the Township with a copy of its rules, regulations and operating procedures on an annual basis by January 15th of each year. Original rules, regulations and operating procedures are to be furnished within 30 days of conditional approval. Amendments occurring in the future are to be furnished to the Township no later than 30 days after their effective date.

Also, to notify Moravian Development Corporation of the Board's action.

RESOLUTION NO. 10-9

Opposition to Forced Local Government Mergers and Consolidations

A RESOLUTION of the Township of Hanover, County of Northampton, the Commonwealth of Pennsylvania, in opposition to forced mergers and consolidations of local governments in Pennsylvania.

Whereas, townships are excellent fiscal stewards that have been doing more with less ever since the days of William Penn and are run by elected officials that live and work in the communities they represent, and are more committed to pinching pennies and working together to stretch tax dollars than anyone else in government today; and

Whereas, various special interests suggest that there are too many local governments in Pennsylvania and that by reducing this figure through forced boundary change will somehow lead to greater economic conditions and the better delivery of services in the Commonwealth; and

Whereas, no one has ever proven that bigger, centralized government is better or even more cost-effective than township government; and

Whereas, governments that rely on consolidated county-based governments generally have higher tax burdens than smaller governments; and

Whereas, recent reports of financially distressed municipalities in Pennsylvania are largely contained to the Commonwealth's large cities and urban areas; and

Whereas, HB 2431 (Session of 2010) would, if adopted, change the Pennsylvania Constitution and establish the county as the basic level of local government in Pennsylvania, with municipalities existing only under the jurisdiction of the county and having only those duties and responsibilities as determined by the county; and

Whereas, SB 1357 (Session of 2010) would, if adopted, establish an unelected, statewide boundary commission to review and make conclusions to the General Assembly for the merger, consolidation, or annexation of municipalities; and

Whereas, the township supports the voluntary merger or consolidation of local governments if the process is initiated at the local level and it has the support of the majority of the residents of all affected municipalities; and

Resolved, that the Township of Hanover, County of Hanover, opposes any measure, initiative, or plan that mandates the forced merger or consolidation of local governments; and be it further

Resolved, that the General Assembly be urged to oppose HB 2431, SB 1357, and any similar kind of legislation that has been, or may be introduced in the future to weaken the responsiveness and effectiveness of local government.
