ORDINANCE OF THE TOWNSHIP OF HANOVER, NORTHAMPTON COUNTY, PENNSYLVANIA, GRANTING TO RCN TELECOM SERVICES, INC., A NON-EXCLUSIVE FRANCHISE TO ERECT, INSTALL, MAINTAIN AND OPERATE CABLE SERVICE IN, UNDER, OVER, ALONG, ACROSS AND UPON THE STREETS, SIDEWALKS, ALLEYS, BRIDGES, ROADS, HIGHWAYS AND OTHER PUBLIC PLACES IN THE TOWNSHIP OF HANOVER AND SUBSEQUENT ANNEXATIONS THERETO INCLUDING IN CONNECTION THEREWITH THE RIGHT AND PERMISSION TO ERECT, INSTALL, AND MAINTAIN POLES AND TO INSTALL, ATTACH AND MAINTAIN WIRES, CABLES, APPLIANCES AND OTHER FACILITIES TO SUCH POLES AND TO EXISTING UTILITY POLES FOR THE PURPOSE OF TRANSMISSION AND DISTRIBUTION OF CABLE SERVICE: TO PROVIDE RECEPTION SERVICE FOR THE SAME TO THE MEMBERS OF THE PUBLIC DESIRING SUCH SERVICE IN THE TOWNSHIP OF HANOVER, AND FOR OTHER PURPOSES FOR A PERIOD OF YEARS, SETTING FORTH CONDITIONS ACCOMPANYING THE GRANT OF THE SAID FRANCHISE; PROVIDING FOR TOWNSHIP REGULATION AND USE OF THE SYSTEM AND PROVIDING PENALTIES FOR VIOLATIONS.

Adopt Resolution 10-12 Establishing the Fees and Charges for Permit Extensions

Mr. Nagle moved that the Board adopt the following Resolution Establishing Fees and Charges for Permit Extensions relating to Senate Bill 1042 also known as Act 46 of 2010:

RESOLUTION NO. 10-12

A RESOLUTION OF THE TOWNSHIP OF HANOVER, NORTHAMPTON COUNTY, PENNSYLVANIA, ESTABLISHING THE FEES AND CHARGES FOR PERMIT EXTENSIONS

WHEREAS, on July 2, 2010, the Governor of the Commonwealth of Pennsylvania signed into law Senate Bill 1042 also known as Act 46 of 2010 (the "Act"); and

WHEREAS, Article XVI-1 of the Act deals with Approval (as that term is defined in the Act) extensions; and

WHEREAS, pursuant to the Act, a municipality has a right to charge a fee for requests for verifications of Approvals as well as a fee for automatic Approval extensions.

NOW, THEREFORE, BE IT RESOLVED and it is RESOLVED by the Board of Supervisors of Hanover Township, Northampton County, and Commonwealth of Pennsylvania, as follows:

- 1. For the Township's written verification of the existence and extension of a valid Approval through the Extension Period (as that term is defined under the Act), a fee up to One Hundred Dollars (\$100.00) for written verification of a residential Approval and Five Hundred Dollars (\$500.00) for written verification of a commercial Approval must be paid to the Township ("Approval Verification Fee"). The Approval Verification Fee shall be paid by the requester at the time a written request for verification is submitted to the Township.
- 2. Pursuant to the Act, the Township hereby imposes a fee to extend an Approval which shall be no more than twenty-five percent (25%) of the original application fee and, in no event, may that fee be more than Five Thousand Dollars (\$5,000.00) ("Approval Extension Fee"). An owner or developer who obtains an automatic extension pursuant to the Act shall be billed the Approval Extension Fee immediately by the Township. The Approval Extension Fee shall be paid within thirty (30) days after it is sent to the owner or developer. Nonpayment of the Approval Extension Fee shall result in immediate legal action for collection of the same.

Approve to Endorse Resolution Amending Article IX of the Second Class Township Code

Mr. Nagle moved that the Board approve to endorse the following Resolution and forward the same to the Northampton County Association of Township Officials for action at their October 1, 2010 meeting:

"Resolution to amend Article IX of the Second Class Township Code to empower Townships of the Second Class to opt out of having an elected Board of Auditors and adhere to Section 917 of Article IX of the second Class Township Code. Townships would be required to pass an Ordinance/Resolution opting into Section 917 as well as an accompanying Ordinance/Resolution prohibiting elected Township Supervisors from being employed full-time by the Township."
