 - Noted that he was re-elected Chairman of the Northampton County Gaming Committee
 - Distributed the Fire Company report
 - Noted that as the number of snowstorms increase, the number of snow emergency parking citations have decreased. There were only 20 citations issued this past storm compared to 50 during the previous storm. There are a couple repeat offenders and Mr. Broughal is in the process of preparing an ordinance that will allow us to have vehicles towed and be compliant that they will be towed to a secure lot.
 - Streets that do not have the appropriate signage posted, those residents will
 receive reminder postcards advising them that they should not be parked on the
 street during a snow emergency.
 - In regards to sidewalks during snow, residents who do not clear their sidewalks will receive a "warning" reminder postcard and if they do not comply the next time, then a citation will be given.
 - Noted that we have received calls from residents asking that their street be posted as snow emergency because of residents who do not want to comply and it would help the public works department if the cars were moved.
 - Asked for the Board's direction on a certain resident who has contacted the Board. Mr. Diacogiannis directed the Manager to respond to the issues in question.
