- 4. The Applicant/Owner shall receive State approval for an Outdoor Play Yard/Controlled Entrance with fence (yard size to be determined – 40 feet x 48 feet testimony, versus 48 feet x 54 feet shown on Conditional Use Plan). The fence shall be, as testified, split rail with 4-foot high nonclimbable coated wire on the inside.
- 5. Building Permits shall not be issued until Conditions 1 through 4 are completed to the satisfaction of the Township Manager, Township Zoning Officer, Township Engineer and Township Solicitor.

He is not going to continue to challenge the Ordinance in place at that time, based on this Ordinance which now meets State and Federal statutes. They are holding informational sessions throughout Northampton County starting in August on the new requirements and penalties.

The Township sent a letter to every employer in Hanover Township, Northampton County encouraging the employers to attend one of the sessions. We also sent reminder postcards out today.

Information is on our website and was handed out at voter polling areas.

Included in this change are requirements for employees to certify themselves to their employer as to what their tax districts are.

The Fire Company report was distributed.
