#### **PAYROLL CHECK POLICY**

It shall be a policy of the Board of Supervisors that in the case of a lost or destroyed payroll check, the affected employee will be charged the fee of \$25.00, which includes current bank & payroll processing charges, to cover the cost of re-issuing such a check.

The Township will then replace said payroll check within seven (7) business days of notification by affected employee. If the net result of the \$25.00 fee results in a check being issued for an amount less than \$25.00 the balance will be included or deducted from the next scheduled check.

Mr. Tanczos moved that the Board approve to grant Domenic Villani, Developer of the Dewire Estates Subdivision an extension to October 31, 2011 to complete subdivision improvements conditioned upon Letter of Credit No. EB-1542011P, issued by Embassy Bank remaining in effect; and to notify the Developer of the Board's action.

Mr. Villani was present to discuss the project and obtain clarification from the Board on where he stands as a Developer and what is required on his part.

Mr. Finnigan stated that Mr. Villani originally asked for a 5 year extension to 2016; at the direction of the Township Solicitor; we have no problem granting that extension; but Mr. Broughal would like an updated improvements agreement put in place and additional security. The MPC gives the Board the latitude that for each year we grant an extension, we increase the security by 10% of the original bond. The original motion was presented to give Mr. Villani to October 31, 2011 to update the agreement and obtain and provide additional security.

After a discussion, Mr. Tanczos amended his motion to grant an extension until December 1, 2011for Mr. Villani to update the improvements agreement and obtain and submit additional security.
