#### **Discussion – 2012-2017 Municipal Waste and Recycling**

Mr. Finnigan stated that he has been contacted by some of the bidders for the Township Refuse and Recycling Services requesting to submit additional information. Mr. Finnigan stated that per the Township Solicitor, the Township will not be accepting any supplemental information.

Mr. Broughal stated that if the Board was going to hear any comments from those bidders present tonight; they would have to re-open the bids and allow those who are not present to state their comments; however he is advising the Board that they do not allow any comments at all.

Mr. Nagle commented on the 1, 2, and 4 day options. He is concerned about going from a 2-day to a 4-day schedule based on certain criteria; aesthetics, more back-ups on a 4-day if there are truck break downs or snow storms; and from a resident standpoint – change.

Mr. Salvesen commented that it is not in the Townships best interest to change the schedule from what it is now and has similar concerns as Mr. Nagle. He stated he would stay with the two-day option.

Mr. Tanczos commented that from a business standpoint, he is concerned about the overall costs to the residents and that with the economy the way it is, he believes the resident will be concerned about lowering the fees.

Mr. Diacogiannis commented that he is "in between" on his feelings. He agrees with Mr. Nagle's comments; however from a dollar standpoint, we need to look at the

savings to the residents. His main concern also is the "cushion" on scheduling and manpower if there are backups if we go with a 4-day schedule.

Mr. Finnigan addressed the Board's concerns on the types of bidders; the number of times the Township notified residents on back-ups whether from equipment or weather; and stated that from his review of the bidders, he is satisfied that all 4 bidders will be able to get the job done. Mr. Finnigan stated that in regards to change; the overriding issue appears to be the cost; cost in the budget is passed on to the residents. We need to do what is in the resident's best interest as well as the Townships. Mr. Finnigan stated that we are better equipped to manage the change by using the newsletter, website, electronic monthly newsletters and even a letter from the Chairman; and stated that we can manage change better if the change comes with benefits.

Mr. Broughal again advised the Board on hearing comments from the bidders present tonight.

Mr. Sam Augustine and Mr. Al DiGennaro were present from J.P. Mascaro. Mr. Augustine stated that the Board held a great discussion on the subject and started to explain his position on the additional information. Mr. Broughal again reiterated his position and Mr. Diacogiannis did not allow any further comments.

### PUBLIC WORKS

It was noted that there were no items on the Agenda.

### Flavor Right Foods – Conditional Approval Status
