Bushta from the firm of Gneiding, DeSanctis, Blizard, Bushta & Company, CPA's LLP, to act as the Certified Public Accountant and to make an examination of all the accounts of Hanover Township, Northampton County, for the 2012 Fiscal year and who shall replace the elected auditors of the Township insofar as it deals with the examination of Township accounts.

Introduction of Resolution 2012-6, Organization of Special Events Committee

Mr. Nagle introduced the following Resolution which will be adopted at the February 14, 2012 Board meeting:

HANOVER TOWNSHIP, NORTHAMPTON COUNTY RESOLUTION NO. 12-06

WHEREAS, the Board of Supervisors of Hanover Township, Northampton County, Pennsylvania (the "Board") recognize the need to create a committee of Hanover Township,

Northampton County, Pennsylvania ("Township") residents to guide and direct special events within the Township which are approved by the Board; and

WHEREAS, the Board created the "Special Events Committee" to facilitate and properly organize the special events within the Township that the Board desires to officially recognize by Resolution No. 01-01.

NOW THEREFORE, be it resolved and it is resolved, that the Board hereby amends Resolution No. 01-01 as follows:

- 1. <u>Purpose of Special Events Committee:</u> To organize, guide, direct and facilitate those "special events" within the Township which are officially recognized by the Board.
- 2. Organization: The Special Events Committee shall (A) consist of not more than seven (7) members, whom shall be Township residents or interested non-residents (maximum of two non-residents) and whom shall be appointed by the Board; (B) the terms of the members shall be three (3) years except for the initial terms of four (4) of the members whose terms shall be staggered with one (1) member having an initial term of two (2) years and three (3) members having initial terms of one (1) year; (C) the members shall select a Chairman, Vice-Chairman, Secretary and Chief Fundraiser, who shall serve at the pleasure of the members of the Special Events Committee and shall be Township residents; (D) the terms shall be on a calendar year basis with appointments to the Special Events Committee being made by the Board at their annual reorganization meeting in January of each year or as vacancies occur; and (E) the Special Events Committee shall meet on the third Tuesday of every month with written minutes to be taken and forwarded each month to the Board and Township Manager.

Authorize Chairman to Execute the DocSTAR System Software Support Agreement

Mr. Nagle moved that the Board authorize the Chairman to execute the DocSTAR System Software Support Agreement between Hanover Township and TOPP Business Solutions for the period March 15, 2012 through March 15, 2013 at the total price of \$3,087.00.

Mr. Salvesen seconded the motion.

Discussion and Award of Residential Waste & Recycling Bid

A discussion was held on the Township's Waste and Recycling contract and the following comments were heard:

Resident, Blair Bates, 4318 Kathi Drive stated cheaper is better, better possibility of the pick-up being done quicker if it is broken down into sectors and stated he prefers the 4 day option.

Sam Augustine, Director of Sales for J.P. Mascaro stated they were low on the 1 day option for the entire Township. He commented that 5 years ago, the Board indicated they wanted the Township picked up in the least number of days and went from a 1 day pick-up to a 2 day pickup. Mr. Augustine stated that they are the low bidder for the 1 day option at \$36.00 less per household than what we are now and understands that these are difficult economic times; however he feels that there are many reasons beneficial to the Township by going to the 1 day

option and asked that the Board take into consideration his comments are stated that they appreciated the Township's contract over the last 5 years and would like nothing more than to continue serving the Township.

Ken Anderson, Republic Services, dba Raritan Valley Disposal stated he attended the last meeting and heard the comments; stated they are pleased with the bid opening with respect to the options the Township is considering. Mr. Anderson stated that Republic Services is the low bidder for the 4 day option with 4 sectors and thanked the Board for the opportunity and stated if awarded, they are ready to serve the Township.

Mr. Nagle reiterated his comments from the last meeting, distributed a spreadsheet he created and discussed the outcome. Mr. Nagle stated we need to look at the Township as a whole and see what our best value is. Mr. Nagle stated that we can offer a reduction in cost and increase the service by going with 1 day pick-up and recommended that the Township look at the lowest bid of the 1 day option as the best value.

Mr. Salvesen stated he reviewed the options further and because of the economic times and the residents having to pay this bill in a lump sum and seeing the overwhelming lower cost; he would have to go with the 4 day, 4 sector option.

Mr. Tanczos stated it is unusual that this Board has conflicting views but looks at it as a good thing. He stands with his comment from the last meeting of looking at this from a business standpoint and getting the residents the cheapest rate.

Mr. Walbert stated that his personal preference would be 1 day a week; however, looking at the Township as a whole, his vote would have to do with the bottom line costs to the residents. Because of that, he stated he would have to go with the 4-day option. Mr. Walbert stated that J.P. Mascaro has done a great job, as well as the haulers before them.

Mr. Diacogiannis stated that his main concern was pricing and because of that he also would go with the 4-day option. Mr. Diacogiannis stated that since the last meeting he reviewed all the bid packages; which were very well presented; and stated that his administrative and operational concerns have been addressed and is confident that whatever way the Board votes, the Township will receive the best service.

Mr. Finnigan mentioned the historical package he distributed to the Board that included previous bid processes and previous haulers and information. Mr. Finnigan also stated he has three different motions and has the updated 2012 rates that pertain to whatever option the Board approves.

Mr. Nagle moved that the Board approve to award the Municipal Waste and Recycling Bid using the Alternate Option – 4-day pick up – 4 sectors to Republic Services of NJ d/b/a Raritan Valley Disposal, 1200 Irving Street, Allentown, PA, 18109 at a total price of \$4,727,546.85 for the period of April 1, 2012 through December 31, 2017 and to notify Republic Services of NJ of the Board's action and to authorize the Township Secretary to notify the unsuccessful bidders. Mr. Nagle further moved that the execution of this Contract and the inclusion of all documents are subject to the approval of the Township Solicitor and Township Manager.

Mr. Salvesen seconded the motion.

Mr. Salvesen aye, Mr. Nagle no, Mr. Tanczos aye, Mr. Walbert aye, Mr. Diacogiannis aye. The motion passed by a 4-1 vote.

Authorize Chairman to sign the Independent Contractor Agreement with Lisa Rodriguez for Zumba Classes at the Community Center

I move that the Board approve to authorize the Chairman to execute the Independent Contractor Agreement with Lisa Rodriguez for Zumba Classes at the Hanover Township Community Center.
