# **Presentation: Representatives from Patient First Neighborhood Medical Centers regarding** the Mastellar Property

Mr. Scott Miller, Project Engineer from Stackhouse Bensinger in Reading and Mr. Dean Andrews, Facilities Manager for Patient First were present to discuss their proposed project at the corner of Jacksonville and Schoenersville Road, the Mastellar property, and were looking for feedback from the Board.

Their proposal included a 1 story, 8,000 square foot care facility and medical building which will employee 9 to 12 people, 1 Board certified physician on staff, hours of 8 am to 10 pm, urgent and medical care, full x-ray, full lab, no appointment necessary.

Mr. Diacogiannis noted for the record that the Board does not have a plan in front of them, that this is merely a presentation for some ideas and the Board will be making no judgment. Mr. Diacogiannis advised Mr. Miller that when they are ready to submit a plan they need to start with the Planning Commission and noted that the Planning Commission comments are considered very highly by the Board.

Mr. Diacogiannis stated that his main concern is the traffic at that intersection, the access points and visibility issue with the trees on that property.

Mr. Miller stated they met with the Township Manager and Engineer last week and discussed storm water issues and the trees in the right-of-way.

Mr. Finnigan stated that a lot of the trees on the property are not healthy and are actually a safety issue.

Mr. Jim Montone, business owner on Schoenersville Road, expressed his concerns and opinion regarding the traffic problems that occur at that intersection.

Resident of 2377 Jacksonville Road expressed his concerns on the traffic problems and the trees on the property and noted that the Township already has an existing facility in St. Luke's North and in the next Township over is an urgent care facility on Airport Road.

Mr. Miller stated that they will be working with PennDot for issues on Schoenersville Road.

Karen VanWhy, Ambulance Captain for Hanover Township E.M.S. stated her concerns on the amount of calls that will come in requesting an ambulance to take a patient to a hospital, access for emergency vehicles to get in and out and commented on the "Urgent Care" signage.

Mr. Miller thanked the Board for their time and their comments.

## HANOVER TOWNSHIP, NORTHAMPTON COUNTY RESOLUTION NO. 12-06

**WHEREAS**, the Board of Supervisors of Hanover Township, Northampton County, Pennsylvania (the "Board") recognize the need to create a committee of Hanover Township, Northampton County, Pennsylvania ("Township") residents to guide and direct special events within the Township which are approved by the Board; and

**WHEREAS,** the Board created the "Special Events Committee" to facilitate and properly organize the special events within the Township that the Board desires to officially recognize by Resolution No. 01-01.

**NOW THEREFORE,** be it resolved and it is resolved, that the Board hereby amends Resolution No. 01-01 as follows:

- 1. <u>Purpose of Special Events Committee:</u> To organize, guide, direct and facilitate those "special events" within the Township which are officially recognized by the Board.
- 2. Organization: The Special Events Committee shall (A) consist of not more than seven (7) members, whom shall be Township residents or interested non-residents (maximum of two non-residents) and whom shall be appointed by the Board; (B) the terms of the members shall be three (3) years except for the initial terms of four (4) of the members whose terms shall be staggered with one (1) member having an initial term of two (2) years and three (3) members having initial terms of one (1) year; (C) the members shall select a Chairman, Vice-Chairman, Secretary and Chief Fundraiser, who shall serve at the pleasure of the members of the Special Events Committee and shall be Township residents; (D) the terms shall be on a calendar year basis with appointments to the Special Events Committee being made by the Board at their annual reorganization meeting in January of each year or as vacancies occur; and (E) the Special Events Committee shall meet on the third Tuesday of every month with written minutes to be taken and forwarded each month to the Board and Township Manager.
