Resignation of N. James Sterner from the Hanover Township Planning Commission

Conditional Use Approval – Lehigh Valley Academy – 1560 Valley Center Parkway – Proposed Gym/Auditorium

- 2. The Applicant/Owner shall comply with all outstanding issues contained in a certain correspondence from Hanover Engineering Associates, Inc. dated May 4, 2012 and captioned Lehigh Valley Academy Expansion/Conditional use.

AN ORDINANCE OF THE TOWNSHIP OF HANOVER, NORTHAMPTON COUNTY, PENNSYLVANIA, REQUIRING THAT ALL SINGLE BUILDINGS WITH 50 OR MORE RESIDENTIAL UNITS FURNISH TO THE TOWNSHIP OF HANOVER, NORTHAMPTON COUNTY, PENNSYLVANIA, AN EMERGENCY OPERATIONS PLAN, ESTABLISHING ADMINISTRATIVE PROVISIONS, FEES AND PENALTIES AND REPEALING ALL ORDINANCES INCONSISTENT HEREWITH.
