Drug and Alcohol Awareness Session

Thursday October 21st the Community Center in conjunction with Lehigh Valley Hospital held a Drug & Alcohol Awareness Session geared towards identifying signs and symptoms of Drug & Alcohol use in children. Also participating was the Colonial Regional Police – Sgt. Mike Melinsky, District Justice Barbara Schlegal, State Representative Craig A. Dally and representatives of the Council on Alcohol and Drug Abuse (CADA). The sad part of the evening was that five residents attended!

Sgt. Melinsky brought examples of drugs and drug paraphernalia that have been seized in Hanover Township recently. The displays were impressive and highlighted a serious problem. While we are fortunate to live in one of the premier townships in the Lehigh Valley, we can't be blind to what's happening within our boundaries. Families are being affected by both Alcohol and Drugs by both children and adults.

Plans are underway to hold another session in the Spring and it's imperative that the Community Center be packed so parents can view items that they should be concerned are in the child's possession or signs and symptoms of use. We owe it to our children and it's our responsibility.

SIGNS & SYMPTOMS OF DRUG USE

It is important to keep in mind that if a child shows any of the following symptoms, it does not necessarily mean he or she is doing drugs. The presence of some of these behaviors could be the product of adolescent stress. Others may be symptoms of depression or a host of other problems. Whatever the cause, they warrant attention, especially if they persist or if they occur in a cluster. A mental health professional or a caring and concerned adult may help a youngster successfully overcome a crisis and develop more coping skills, often preventing further problems. The key is change; it is important to watch for any significant changes in your child's physical appearance, personality, attitude or behavior.

PHYSICAL SIGNS

- Loss of appetite, increase in appetite, any changes in eating habits, unexplained weight loss or gain;
- Slowed or staggering walk, poor physical coordination;
- Inability to sleep, awake at unusual times, unusual laziness;
- Red watery eyes, pupils larger or smaller than usual, blank stare;
- Cold and sweaty palms, shaky hands;
- Puffy face, blushing or paleness;
- Smell of substance on breath, body or clothes;
- Extreme hyperactivity and excessive talkativeness;
- Runny nose & hacking cough;
- Needle marks on lower leg or bottom of feet;
- · Nausea, vomiting or excessive sweating
- Tremors or shakes of hands, feet or head; and
- Irregular heartbeat

BEHAVIORAL SIGNS

- Change in overall attitude/personality with no other identifiable cause;
- Change in friends, new hang-outs, sudden avoidance of old crowd, doesn't want to talk about new friends & friends are known drug users;
- Change in activities or hobbies;
- Drop in grades at school or performance at work, skips or is late for school;
- Change in habits at home, loss of interest in family or family activities; and
- Difficulty in paying attention & forgetfulness.

LEAF COLLECTION

Leaf Collection began in Mid-October and will continue to the end of November or the first week of December depending on weather conditions.

Please place your leaves along the front of your property, in a windrow. (see picture below)

Please try to keep any rocks or bricks out of the piles. Keep cars clear of all piles.

Please be aware that leaves are picked up as soon as possible. Due to the amount of leaves and weather conditions we sometimes get behind, please be patient and do not call the office. Thank-you for your cooperation!

PARKING DURING SNOW STORMS

Please, please, please when SNOW is in the forecast please make every effort to keep all your vehicles in your driveway. This is a problem in the following areas: All Cul-de-Sacs, plus Grace Avenue, Jaclyn Lane, Overlook Drive, Briarstone Road and Rosewood Drive.

With everyone cooperating, we can all have cleaner and safer streets after a snow storm. Please be aware that the township usually needs to plow each street at least 2 times and sometimes even more depending on the severity of the storm.

SNOW & SIDEWALKS

Please remember if you have sidewalk adjoining your property all snow must be removed within 36 hours after a storm. Please do not shovel snow into the streets!

PROPERTY OWNERS

Please note that the when time permits the Township trim's trees overhanging the roadway, to provide proper clearance for vehicles. If you do not want your trees trimmed by the Township please have your trees trimmed regularly. Property owners who live on corner properties should also be aware that you should not plant anything in the "Clear Site Triangle".

Shrubs and pine trees overhanging the road have also become a problem. Please keep all trees and shrubs behind the rear face of curb.

Proper clearance for pedestrians walking on sidewalks has become a problem in some areas. Please remember this can be a liability to you.

Dumping grass clippings or ANY debris on empty lots is against the Township Ordinance 71-5. Violators will be fined up to \$300.00.

ALARM SYSTEM OWNER'S

Please remember if you have a Monitored Alarm System or Automatic Protection Device it must be registered with the Township. (Ordinance 96-1)

SHADE TREE COMMISSION

Late fall is a perfect time to plant new trees. If you would like to beautify your property, do it now. After planting, water your new tree well and be sure to spread mulch 2-3 inches thick in a wide diameter around the tree, without piling it up around the trunk. Studies have shown that trees enhance property values and, when properly placed, reduce heating and cooling costs.

Three reminders:

You may not cut down a live tree in the Township right-ofway without permission from the Shade Tree Commission.

If a tree dies in the Township right-of-way, you must replace it with one from the Approved Tree list.

Call the Township Office with any questions or to get a permit and tree list. Also available is a free Tree Care brochure from the Shade Tree Commission.

s computers and the Internet have become more integrated with our daily lives, a whole new array of fraudulent activities has arisen. That's why this October government was working with private industry and organizations to promote Internet security through National Cyber Security Awareness Month 2004.

Using the Internet, scam artists and disreputable businesses are hoping to trick people into disclosing personal information through official-looking e-mails or pop-up messages.

They may ask for your Social Security number, your bank account information, your credit card numbers, your passwords or other personal information. The problem is slowly becoming an epidemic and people must be extremely careful about who they're dealing with online.


According to the Federal Trade Commission (FTC), scam artists typically send an e-mail message that falsely claims to be from a business or group with which consumers may have a relationship. The message usually asks recipients to "validate" or "update" account information, and may threaten to terminate an account if the consumer does not respond. The message may direct recipients to update their information on a Web site that looks real, but is not.

To avoid getting hooked by a scam, consumers should do the following:

- If you get an e-mail or pop-up message that asks for personal or financial information, do not reply or click on the link in the message. Legitimate companies will not ask for this information via email.
- If you are concerned about the status of your account, contact the organization in the e-mail using a telephone number you know to be legitimate.
- Do not send personal or financial information via email; it is not a secure method of transmitting such information.
- Be cautious about opening any attachment or downloading any files from e-mails, regardless of who sent them.
- Use and update your computer's anti-virus software and install a firewall. E-mails may contain unseen attachments that can harm your computer, but installing appropriate security measures can protect you from accepting such unwanted files.
- Review bank account and credit card statements to look for any unauthorized charges.

The Internet is a great resource for information and an excellent way to stay in touch with family and friends, but the increasing number of online scams should be a warning. Consumers who wish to report suspicious activity to the FTC can visit the agency's website at www.ftc.gov or call toll-free, 1-877-FTC-HELP.

Property Tax Reform: Step One

t is time for homeowners to take the first step toward securing future property tax reductions. You should have received property tax reduction, applications from

the Bethlehem Area School District. For homeowners to receive a property tax reduction they must complete and return applications to the county tax assessment office by March 1, 2005.

This certifies their property is owner-occupied and entitles them to the reduction if the school district opts into the property tax relief plan. Homeowners are also reminded applications must be on file with the county assessment office in order for them to receive tax relief.

The tax relief plan is based on the amount of funding available in the Property Tax Relief Fund. Reductions will vary for property owners in each school district.

Revenue for the fund will come from profits derived from slot machines.

In July Gov. Ed Rendell signed legislation to allow up to 61,000 slot machines at 14 sites -- seven of which are race-tracks -- across the Commonwealth of Pennsylvania. When promoting the slots legislation the \$1 billion figure in tax

relief was touted by the bill's supporters. Thirty-four percent of the profits from slots go to the state for property tax reductions.

> The amount of relief distributed to each school district is based on a formula using the state funding ratio and tax levels of a school district.

> Although contingent upon sufficient funds in the Property Tax Relief Fund, the first reductions could be delivered as early as 2006. From what I can tell, it may be several months until the first coin is legally dropped into a Pennsylvania slot machine so 2006 may be optimistic, too.

> The law also gives voters the option of offsetting property taxes by up to 50 percent of the median assessed value by substituting an earned income tax. At the same time, future

school tax increases above the cost of living would have to be approved by the voters as well.

The bottom line is homeowners will have to act to complete this application to obtain property tax relief no matter the timing or the amount of the relief

EX-COP'S AFFECTION FOR RIDE UNBRIDLED

Back in his native New York City, Keith Levine was just another working stiff — one of roughly 100 police horses in the department's mounted unit. But in Keith's adopted Lehigh Valley home, his gentle nature made him an instant celebrity, said Joe Perno, who patrolled The Big Apple atop the horse for a decade before retiring to Bethlehem Township in 2002.

When Keith followed suit and retired to Koehler's Stables in Hanover Township last year, he and Perno, 45, began giving talks at area schools, senior centers and churches, and walking in holiday parades. And Keith became the East Hills Middle School band's unofficial mascot.

While Perno described their work together, people would marvel at his equine partner's obedience and good temper, he says. "He was just delightful." Even folks who were frightened by big animals warmed to Keith, Perno said. "He was so gentle that they were able to hold apples in their hands and he would eat them."

On Sept. 25, shortly after he and Perno made a public appearance, Keith died, probably from complications of equine West Nile virus, Perno said. He was between 20 and 22 years old. Named for an NYPD sergeant shot trying to stop a robbery in 1991, Keith struggled to beat the swift-moving illness. His partner was there with him at the end. "He was laying on my knees and I was petting his neck," Perno said.

Keith also suffered from a chronic upper respiratory infection and navicular syndrome, a hoof disease. Perno moved Keith from Manhattan because he thought it would improve the horse's health and because he missed him, he said.

Keith's death was unexpected and tough to deal with for

Perno, his wife, Catherine, and their three children, who considered the horse a member of the family. Perno had Keith's remains cremated, and now his ashes are displayed in the family's living room with photos and other reminders of the horse, he said.

"Now, I get to see him every morning and I get to see him every night," Perno said. Even though Keith is gone, Perno plans to keep on telling Lehigh Valley residents about what it's like to be a mounted police officer, he said. "I've gotten so many cards from people saying they want me to continue to talk even though I don't have him any more. They've been very supportive."

Without Keith, Perno won't be able to do much in the way of demonstration, but he can still share anecdotes about all the times he and his horse worked crowd control at parades and demonstrations.

Or the times he and Keith escorted past U.S. presidents or patrolled New Year's Eve celebrations in Time Square. Or the time they guarded the perimeter of ground zero after the Sept. 11, 2001, terrorist attacks on the World Trade Center. Perno cherishes every memory of his time with Keith, but it's the little things that he misses most, like riding the horse on local streets or feeding him treats at the stable.

"He'd eat carrots out of my mouth. It looked like he was giving me a kiss," Perno said. "He put a smile on my face all the time."
