Wawa, Inc.3300 Schoenersville RoadConditional Use ApplicationNo one was present representing Wawa.

Wawa proposes to convert four (4) existing "gasoline only" fueling positions to combined "gasoline/diesel" fueling positions. Site is located within the PORR District (Planned Office, Research and Residential).

Previously approved Conditional Use Plan and Preliminary/Final Land Development Plans include notes prohibiting diesel fueling stations on this site. Zoning Ordinance stipulates that providing diesel fuel is not a permitted use. A Variance request, prior to proceeding with the request for Conditional Use, may be required. Determination must be made by the Zoning Officer and/or Township Solicitor.

Planners have concerns they would have wanted discussed.

Will tractor trailers access Stoke Park Road?

Would there be restrictions allowing only passenger vehicles only as opposed to also allowing fleet vehicles and tractor trailers?

Maneuverability for tractor trailers is questionable. Turning templates would need to be provided.

Motion was made by Vail, seconded by Lawless, to recommend to the Board of Supervisors to defer the decision on the Applicant's proposal until such time as the Zoning Officer has rendered an opinion as to the suitability for the proposal in the PORR District and the Planning Commission's review of the same.
