#### Approval of Resolution 14-10, Establishing Sewer Rates, Rules and Regulations

Mr. Nagle moved that the Board approve the following Resolution, 2014-10 establishing Sewer Billing Rules and Regulations:

#### HANOVER TOWNSHIP NORTHAMPTON COUNTY

Resolution <u>14-10</u>

*WHEREAS*, Ordinance 07-17, Section 140-3 of the Township of Hanover, Northampton County, allows for the establishment of rates, rules and regulations, as from time to time may be amended by resolution of the Township; and

*WHEREAS*, in keeping with good practice, the Board of Supervisors of the Township of Hanover periodically reviews the rates, rules and regulations and makes appropriate revisions and/or modifications.

*NOW, THEREFORE, BE IT RESOLVED*, and it is resolved and enacted that the Sewer Billing Schedule as set forth on *Exhibit "A"* attached hereto is established and that the following rules and regulations with respect to Sewer billing is hereby established:

- (a) Sewer bills shall be billed quarterly, in arrears;
- (b) Sewer bills due net thirty (30) days;
- (c) Sewer bills shall accrue a 10% penalty if not paid within forty-five (45) days of billing; and
- (d) Sewer bills shall accrue interest monthly on any delinquent account at the annual rate of 18.0% or the maximum permitted by law.

That any resolution, or part of resolution, inconsistent with this Resolution be and the same is hereby repealed insofar as the same affects the matters contained in this Resolution.

*IN TESTIMONY WHEREOF*, the undersigned TOWNSHIP has caused this Resolution to be signed by a duly authorized officer and its corporate seal, duly attested by the Board Secretary, to be hereunto affixed this 28<sup>th</sup> day of October, 2014.
