#### **ORDINANCE NO. 16-1**

AN ORDINANCE AMENDING AN ORDINANCE ENACTED BY THE BOARD OF SUPERVISORS OF HANOVER TOWNSHIP, NORTHAMPTON COUNTY, PENNSYLVANIA, ENACTING RESTRICTIONS ON THE USE OF BRAKE RETARDERS ON CERTAIN ROADS WITHIN THE TOWNSHIP BY ADDING AN ADDITONAL ROAD WITH THE SAME RESTRICTIONS AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES INCONSISTENT HEREWITH

NOW, THEREFORE, be it enacted and ordained by the Board of Supervisors of Hanover

Township, Northampton County, Pennsylvania, and the same is hereby ordained and enacted as follows, to

with

<u>SECTION 1</u>. The Supervisors of Hanover Township, Northampton County, Pennsylvania, under the powers vested in them by the "Second Class Township Code" and the "Pennsylvania Motor Vehicle Code," as amended, as well as other laws of the Commonwealth of Pennsylvania, do hereby ordain and enact the following amendment to Ordinance 07-09, Article III, Chapter 172.

SECTION 2. Pursuant to the Pennsylvania Motor Vehicle Code and the regulations of the Pennsylvania Department of Transportation, Hanover Township obtained a traffic and engineering study from Hanover Engineering Associates, Inc., dated September, 2015, which traffic and engineering study supports the restrictions on brake retarders as hereinafter set forth.

SECTION 3. Ordinance 09-01, Article III, Chapter 172, Section 172-37C of Hanover Township is hereby amended by adding an additional subsection (8) to read as follows:

"(8) Airport Road (SR 0987) between Hanoverville Road and Schoenersville Road (Engine Retarder Restriction Study dated September, 2015)."

<u>SECTION 4</u>. If any section, clause, provision or portion of this Ordinance or regulation incorporated herein shall be held to be invalid or unconstitutional by any court of competent jurisdiction, such decision shall not affect any other section, clause, provision or portion of this Ordinance or regulation.

<u>SECTION 5</u>. All Ordinances and parts of Ordinances inconsistent herewith be and the same are hereby repealed.
