Mr. Stephen McCarthy of 2618 Centennial Drive questioned the board if the sinkholes that are in the retention basins are a concern of the residents or of the Township.

Mr. Kocher advised that the developer has been advised that these must be addressed and the basins cannot be lined or completed until the sinkholes have been filled.
