## DISTILLERIES, LIMITED DISTILLERIES, WINERIES AND LIMITED WINERIES Zoning Ordinance Text Amendment

Proposed Text Amendment was reviewed. The Planning Commission offers the following comments and suggestions.

Page 1 - 2<sup>nd</sup> paragraph Consideration should be given for adding provisions for Meadery, Cidery or a Combination of All Establishments

This would amend the current Ordinance as it pertains to Brew Pubs and Micro Breweries.

Title of the Ordinance should read that it is providing for the establishment of Distillery, Limited Distillery, Winery, Limited Winery, Meadery, Cidery and a Combination of All Establishments

Page 2 - Limited Distillery remove the word leased (....to sell bottled liquors on the premises to the Liquor Control etc))

## DISTILLERIES, LIMITED DISTILLERIES, WINERIES AND LIMITED WINERIES Continued

Page 2 - Distillery - 4<sup>th</sup> line add for human consumption (....production of alcohol for human consumption.)

Page 2 - Winery - 2<sup>nd</sup> line add applicable processes (.... is produced by the applicable processes by which (etc))

Page 2 - Winery - 3<sup>rd</sup> line from bottom replace the with a before "proper agency" (promulgated by a proper agency (etc))

General Comments with regard to SECTION 2 – Article II – Interpretations and Definitions; Section 185-12 Definitions

Solicitor is requested to examine whether the Federal Regulatory language contained in the Winery definition should also apply to the Distillery definition.

Brew Pub definition states on-premises consumption. If it is the Township's intent for all types of these facilities to have on-premises consumption, each definition should state on-premises consumption.

Page 3 - Section 4 - G (3) Microbrewery This is listed, however, there is no definition given for Microbrewery under Section 2.

There is no definition for Meadery, Cidery or Combinations.

Pages 5 and 6 - Section 8 under 24(b) for Distillery, 25(b) for Limited Distillery, 26(b) for Winery, and 27(b) for Limited Winery replace the word Only with A maximum of (A maximum of (30%) percent of the floor (etc))

Conform these sections to include Meadery, Cidery and Combination Establishments.

Motion was made by Lawless, seconded by Check to send a letter to the Board of Supervisors advising them of the Planning Commission's comments and suggestions.
