Turkey Hill Liquor License Transfer Ordinance

Mr. Tanczos recused himself.

Mr. Prendeville moved the Board approve to adopt Ordinance 2017 - 8 approving the transfer of restaurant liquor license No. R-15327 into Hanover Township, Northampton County,

Pennsylvania from the Township of Washington, Northampton County, Pennsylvania, pursuant to the Pennsylvania Liquor Code.

Mr. Finnigan advised the Solicitors office has prepared the Ordinance as well as the Resolution required should the Board deny the Ordinance. The resolution requires the Board list reasons if the resolution is passed.

Mr. Salvesen no, because liquor licenses should be given to restaurants and he stated concern that there would not be one specific individual supervising the sale of the alcohol, Mr. Nagle no, because it is ill advised to have consumable alcohol at a destination for gas to operate a vehicle, Mr. Prendeville no, the density of the liquor licenses has a negative effect on the surrounding neighborhoods, stating the potential risk far outweighs the benefit, Mr. Diacogiannis yes, because the decision for this does not belong at the Township level, it has already been decided by the State level.

Mr. Finnigan read Resolution 17-10:

RESOLUTION 17 - 10

WHEREAS, Turkey Hill, L.P., filed an application with the Township of Hanover, Northampton County, to approve the transfer of Restaurant Liquor License No. R-15327 to be utilized at its facility at 6020 Sterner's Way, located within the Township of Hanover, Northampton County, Pennsylvania, pursuant to the Pennsylvania Liquor Code; and

WHEREAS, the Board of Supervisors of Hanover Township, Northampton County, Pennsylvania held a Public Hearing on the request for the transfer of the Liquor License on April 25, 2017, and received testimony from the Applicant, Turkey Hill, L.P., and residents of the Township of Hanover, Northampton County, Pennsylvania; and

WHEREAS, The Board of Supervisors of Hanover Township, Northampton County, Pennsylvania now desire to act on the requested approval of the transfer of the Liquor License as required by the Pennsylvania Liquor Code.

NOW, THEREFORE, BE IT RESOLVED and it is *RESOLVED* that that application for the approval of the transfer of Restaurant Liquor License No. R-15327 to Turkey Hill, L.P., for 6020 Sterner's Way, Hanover Township, Northampton County, Pennsylvania is hereby denied for the following reasons:

- Lack of supervision over the sale of alcoholic beverages
- Health and wellbeing of the Township
- Density of liquor licenses in the Township
