- D. Prepare on an annual basis a Policy & Procedure to deal with walk-aways from the memory care unit and provide the same to the Township.
- E. Use management and security measures pertaining to the storage of controlled medications, including opioids and psychotropic medications.
- F. Obtain Preliminary/Record Lot Consolidation and Land Development Plan Approval from the Board of Supervisors for the 140-bed assisted living and memory care facility.
