583 Trip Improvements Closeout**


Dear Supervisors:

This is to report to you that the Route 512 corridor/Broadhead/Crawford intersection improvements, Crawford/Jacksonville generator transfer switch, and the eastbound Route 22 ramp signal timing have all been completed. Jaindl is waiting for final PennDOT inspection and official closeout of this work.

Based on the foregoing, I would assume that no time extension is necessary from the Township. However, recognizing that the last time extension ran through October 31, 2020, I wanted to bring this to the Board's attention. If you do believe that a time extension is needed then we request that extension be granted until completion of the PennDOT inspection and closeout.

UPDATED REQUEST PER TOWNSHIP DIRECTION: We have been asked to request a specified date for this time extension. Accordingly, we request an extension of time through the end of July 2021 to complete the final inspections and closeout items with PennDOT and the Township. Thank you.
