RESOLUTION NO. 2021 - 7

RESOLUTION APPROVING THE CHANGE OF INDIRECT CONTROL OF THE FRANCHISEE UNDER THE CABLE TELEVISION FRANCHISE

WHEREAS, RCN Telecom Services (Lehigh) LLC ("Franchisee") owns, operates and maintains a cable television system (the "System") in the Township of Hanover (Northampton Co.) pursuant to a cable television franchise ("Franchise") granted by the governing body of the Township of Hanover (Northampton Co.) (the "Franchise Authority"), and Franchisee is the current duly authorized holder of the Franchise; and

WHEREAS, pursuant to an Agreement and Plan of Merger ("Agreement"), funds associated with Stonepeak Infrastructure Partners ("Acquiror"), a Delaware limited liability company, will purchase 100% of the membership interests of Radiate Holdings, L.P., a Delaware limited partnership, (which owns 100% of the indirect ownership interests in Franchisee), and, as a result, the indirect control of Franchisee will change (the "Change of Control"); and

WHEREAS, Franchisee and Acquiror have requested the consent of the Franchise Authority to the Change of Control in accordance with the requirements of the Franchise, have filed an FCC Form 394 with the Franchise Authority, and have provided the Franchise Authority with all information necessary to facilitate a decision by the Franchise Authority (the "Application"); and

WHEREAS, the Franchise Authority has reviewed the Application, examined the legal, financial and technical qualifications of Acquiror, followed all required procedures in order to consider and act upon the Application, considered the comments of all interested parties, and finds Acquiror to be suitable to indirectly control Franchisee.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

SECTION 1. The Franchise Authority hereby accepts the Application and consents to the Change of Control, all in accordance with the terms of the Franchise and applicable law.

SECTION 2. The Franchise Authority confirms that the Franchise is valid and outstanding and in full force and effect and there are no defaults under the Franchise. Subject to compliance with the terms of this Resolution, any action necessary with respect to the Change of Control has been duly and validly taken.

SECTION 3. This Resolution shall be deemed effective as of the date of its passage. This Resolution shall have the force of a continuing agreement with Franchisee and Acquiror, and Franchise Authority shall not amend or otherwise alter this Resolution without the consent of Franchisee and Acquiror.

HANOVER TOWNSHIP, NORTHAMPTON COUNTY RESOLUTION 2021 – 8

A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE TOWNSHIP OF HANOVER, NORTHAMPTON COUNTY, COMMONWEALTH OF PENNSYLVANIA URGING ALL PENNSYLVANIA LEGISLATORS TO OPPOSE GOVERNOR WOLF'S PROPOSAL TO LEVY A FEE ON ALL LOCAL GOVERNMENT FOR THE FUNDING OF PENNSYLVANIA STATE POLICE.

WHEREAS, Hanover Township is a municipal corporation located in Northampton County, Commonwealth of Pennsylvania, which is governed by the Second Class Township Code; and

WHEREAS, the Second Class Township Code authorizes a municipality to provide for police services for the public health, welfare and safety; and

WHEREAS, Hanover Township has maintained and funded full-time police coverage since 1995 through an inter-municipal agreement, which resulted in the creation of the Colonial Regional Police Department; and

WHEREAS, Hanover Township's budget for police services in 2021 is \$2,269,333, which represents 25% of the total 2021 budget of \$9,042180; and

WHEREAS, Governor Wolf has made a recent proposal that would require all municipalities to pay a fee to the Commonwealth of Pennsylvania for funding for the Pennsylvania State Police; and

WHEREAS, under Governor Wolf's proposal, Hanover Township would pay the Commonwealth of Pennsylvania an additional \$84,849.33; and

WHEREAS, it is the belief of the Board of Supervisors of Hanover Township that the implementation of a fee for municipalities that already pay for full-time police services would be grossly inequitable and an unjust assessment.

NOW THEREFORE, BE IT RESOLVED that the Board of Supervisors of Hanover Township, Northampton County, Commonwealth of Pennsylvania urges our local Commonwealth of Pennsylvania legislators to vehemently oppose any imposition of fees on all municipalities for Pennsylvania State Police coverage as it is an inequitable fee, particularly for municipalities that pay for full-time police coverage independent of Pennsylvania State Police.
