Hanoverview

VINCENT G. MILITE

AUGUST 23, 1964 - JANUARY 9, 2023

How do you condense an individual's life into one Hanoverview article. I unfortunately have that daunting task.

Chairman of the Board of Supervisors summed up Vince's life with these bullet points during the Board's meeting on January 10, 2023. John's Diacogiannis' remarks were, "Vincent G. Milite, Born - August 23, 1964, Eagle Scout, Freedom High School Graduate, Lifeguard, a guardian of life, Teacher of Life, Public Works Extraordinaire, Operations Expert, Manager of

Projects, Dedicated Leader, First Responder, Township Caretaker, Community Cheerleader and Activist, Top Citizen, Loving Son and Brother, Devoted Husband, Dedicated Father, Proud Grandfather, Dutiful Public Servant, End of Duty - January 9, 2023, Friend TO All, Friend OF All. Friend OF Mine."

The day following the Board meeting, Supervisor Barry Check shared this with the Board. "A Scout is: *Vince was:* Trustworthy Loyal Helpful Friendly Courteous Kind Obedient Cheerful Thrifty Brave Clean Reverent" Mr. Check's comments were taken directly from the Scout Oath.

If you review the Minutes from the Board meeting of January 10th on the Township website, you'll be able to see the remarks Supervisors Lawless and Prendeville offered.

My first introduction and recollection of Vince was when our family moved to Hanover in 1997 and we got involved with the activities of the 250th Anniversary Cele-



bration. He was present at all the events. Not just present, but active and engaged. This would continue during my time on the Board of Supervisors and the last seventeen plus years as Township Manager. When I became the Township Manager, Vince was serving as Road Superintendent under Public Works Director Kevin Healy. Vince was being groomed to be Kevin's successor and when Kevin retired in 2009, Vince was promoted to Public Works Director. Vince literally came up through the ranks, starting with the

Township in the early 1980's as a summer life guard.

Vince was a resource to the public works departments throughout the Lehigh Valley. Tom Petrucci, Township Manager – South Whitehall Township commented, "Vince is a huge personal loss to me. When I was a young Borough Manager in Bath, and subsequently a Township Manager in Plainfield Township I was constantly calling Vince to pick his brain on challenging issues. Vince was always willing to take my call, listen and offer suggestions. I'll miss him immensely."

Vince was a devoted, loving, caring son, husband, father, stepfather and his greatest status, a gushing grandfather. Nothing was more important to Vince than his family. They were always foremost in all his thoughts and actions.

The "new" Chairman of the Board of Supervisors is really the "old" Chairman, John Diacogiannis, returning after a brief hiatus. Welcome back John!!

In review, much happened in 2022. Number One, and most importantly, after much research, discussion, and review, a loan was secured, and a vendor was selected to replace the pool. I want to thank the Pool Advisory Board, led by Board Member, Mike Prendeville, Supervisor Susan Lawless, and the Township Staff for their diligence over the past 3 years, working under difficult conditions (Covid, Supply Chain Issues, etc.) to get us to where we needed to be in this project. I believe that we will have a pool that we can be very proud of when it is completed.

The Board has worked through several difficulties in 2022. We were able to convince our wonderful Township Manager, Jay Finnigan, to delay his retirement. We dealt

Our greatest loss was in the first few days of January 2023, was the untimely passing of our Public Works Director, Vince Milite. Vince had been with the Township for about 40 years, starting as a Lifeguard, working his way to the Public Works Staff, and eventually to the Public Works Directorship. Everyone in this Township lost a great neighbor, friend, and public servant. More on Vince in this *Newsletter*.

As I stated in the last *Newsletter*, Christina Thomas has joined our staff as Secretary / Asst. Treasurer and is doing a great job as is Kim Lymanstall our Township Manager Secretary and Sierra Franco, our new Office Support Associate.

After interviewing 8 excellent candidates in October, Barry Check was appointed as a member of the Board of Supervisors. Barry had been a member of the crucial Township Planning Commission for the past 13 years, 6 years as Chairman. Additionally, he has been on the Traffic Impact Committee for 5 years, all as Chairman.

Barry has lived in Hanover 31 years and is married to Susan for 44 years. They have raised 2 children, who are now out on their own. Barry is a graduate of Freedom High School and later graduated from Lehigh as a Civil Engineer. His experience made him an obvious choice as a Supervisor. His expertise will be a great asset to the Township.

My thanks go out to the many Township employees and volunteers that contribute every day to make Hanover Township the wonderful place to Live, Work, and Play.

As big as his physical presence was, he was a teddy bear. Inside that mean, tough, intimidating presence was a cream puff.... a big ass Teddy Bear. Cancer may have ravaged his physical body, but his love, care, and compassion burst through for all to see.

My lasting impression of Vince will be the grace and dignity he fought cancer with for the past four and a half years. Days when most people would be home unable to bring themselves to work, he was in the office working and fighting with every ounce of energy he had, leading by example. Vince was the fabric that bound the Township together.

As I've posted on Facebook, commented at a board meeting, remarked at a memorial event and during a Celebration of Life, our relationship went from boss/subordinate to friend/brother from another mother. Rest in Peace Brother!

Remembering Vince Milite

It is with great sadness that the CRPD, as well as its Commission, recognizes the passing of Vince Milite. Vince was an avid supporter of our police department and went beyond his duties as the Director of Public Works. As one of the Township's Emergency Management Directors, he was the first to respond, day and night, to any serious scene to lend support as needed to the police, fire and emergency medical personnel. Vince took a personal interest in assisting and looking out for needs of the CRPD officers and staff. He was instrumental in raising a considerable

amount of donations for CRPD's annual Shop with A Cop event. His efforts helped to make a lot of children's holiday season a little more normal. We join the many that have been blessed with his kindness over the years.



As you may know, due to retirements and one untimely passing, we have had a relatively large number of new officers joining CRPD over the last few years. Recent years have been difficult for police recruitment. In particular, many cities have had difficulty in filling their ranks. Fortunately, we have not experienced that problem. Last fall, CRPD initiated a competitive officer recruitment and evaluation process. The evaluation and acceptance process are quite involved and designed to identify the best possible candidates. Three qualified candidates were selected and have recently entered the Allentown Police Academy. After graduation this summer, they will join the force and enter field training. They are:

JOSHUA CHICO – originally from Plainfield, NJ, now living in Easton. Joshua graduated from Bridgewater-



Raritan High School. He is 27 years. He served honorably in the US Marine Corps from 2013 to 2017. He earned an associate degree in Computer Information Systems

STERLING KEMMERER – originally from Doylestown and is now living in Quakertown. He is 31 years old. He graduated from Pennridge High School.

MICHAEL CABRERA – from Lower Nazareth Township. He is 21 years old. He graduated from Nazareth Area High School. Michael has been a volunteer with Hecktown Fire Department for the last 6 years.

We look forward to them joining the force. I will have more complete intro-

ductions upon their taking their oath.

CRPD Citizens Police Academy

This past fall, I had the pleasure of joining 20 of my fellow citizens in the 2022 CRPD Citizens Police Academy. This is an 11 week program conducted primarily one night each week, with each session lasting 2 hours. The program is run by our finest at CRPD under the direction of Deputy Chief Michael Melinsky. A Northampton County Corrections Officer presented an eye opening look into gang activity in Pennsylvania. One of our area District Magisterial Judges conducted a mock trial of a criminal case study. Thanks also to the Keystone Rod and Gun Club for graciously allowing us free range time for the Academy participants to experience safe firearms handling practices and marksmanship. For most of them, it was the first time that they handled and fired a firearm.

Multi-Municipal Comprehensive Plan Approved by Township 2022

The proliferation of warehouses in the Valley, the rapid disappearance of farmland, an increase in traffic on key roadways and a lack of affordable housing are just a few of the issues one might have read in any news article concerning life in the Valley over the last year or two. Addressing each of

these weighty issues requires planning and foresight. Planning is occurring at many levels.

Starting at a macro-level, there is the Lehigh Valley Planning Commission ("LVPC"). The LVPC was formed by Lehigh and Northampton Counties in 1961 to create a bicounty comprehensive plan to guide orderly growth in the two counties. The purpose of the LVPC is to promote the health, safety and general welfare of the Lehigh Valley region in accordance with the provisions of the Pennsylvania Municipalities Planning Code (the "MPC"). The MPC is the source from which municipalities, like ours, derive their authority to regulate land use and development within their respective borders. The tools to do so are zoning ordinances, official maps and comprehensive plans. In 2019, the LVPC released a fifth comprehensive plan called FutureLV. FutureLV establishes goals, policies and actions designed to carry the region through at least 2045.

One of the most important functions the LVPC serves is to review most large development plans submitted to municipalities in the Valley. Its review is on an advisory basis only. The purpose of the review is to confirm compliance with Future LV as well as local planning priorities and to identify meaningful deviations therefrom. To meet its mission and goals, the LVPC's staff of professional planners works with its Commissioners who come from among the community it serves. I had the pleasure of serving as an LVPC Commissioner from 2019 through 2022. Chairman Diacogiannis had served as a Commissioner from 2001 to 2019.

A peculiarity of the MPC is that it requires each municipality to provide for an extremely broad array of uses within its borders. This requirement poses considerable

challenges for a community such as ours which is pretty much built-out. In 2019, the Township joined with the Boroughs of Bath, Chapman, Nazareth, Stockertown and Tatamy and the Townships of Bushkill, Lower Nazareth, Moore and Upper Nazareth to create the Nazareth Area Multi-Municipal Comprehensive Plan ("Naz-Plan"). The LVPC guided the municipalities in the process as professional consultant. The purpose of the Naz-Plan is to enable each participating municipality to shape a collective vision for the future.

While the Township retains its autonomy and control, planning as a region enables these municipalities to partner to address common priorities, including the preservation of environmental and historic assets which are of regional importance. Naz-Plan joins the Northern Lehigh Multi-Municipal Comprehensive Plan, the Southern Lehigh County Comprehensive Plan and the Plan Slate Belt group as one more multi-municipal plan in the Valley. FutureLV, the multi-municipal plans and much more can be accessed at https://LVPC.org. With the Naz-Plan in hand as a road map for future development, the next challenge for the Township and its nine partners will be to review and update their respective body of ordinances to insure that they are adequate to meet the aspirations contained in the plan itself. Let the planning continue.

of services helped us select Hanover Township as the place we wanted to live and raise our children.

County Executive Lamont McClure's Perspective

Every December features a wrap-up of the latest trends. Something missing off the 2022 top ten lists—voting. Citizens have been turning out in record numbers in recent years. The 2022 General Election had a turnout of 58.4%—20 points higher than in 2014.



While the higher turnout is better for our democracy,

it does make holding elections more challenging. I'm glad to report that our Election Office staff and volunteers continues to do a great job making sure every eligible citizen can vote and that every eligible ballot is counted.

2023 is an odd number which means this is a municipal year: school directors, mayors, township supervisors, auditors, etc. While not as exciting as a state-wide or national races, local elections have direct impact on your community when it comes to zoning, taxes and services.

If you want to vote by mail this year you will have to reapply. In February, the Elections Office will send reminder letters to those on the permanent list; anyone not on the permanent list can fill out an application at vote.pa.gov

Pennsylvania will hold its primary on May 16th with the polls open from 7 AM-8 PM. The primary is closed so only voters registered as Democrats or Republicans can for vote for candidates, but any registered voter can vote on referendum questions.

As the poet Archibald MacLeish once said, "Democracy is never a thing done. Democracy is always something that a nation must be doing."

I hope everyone votes this year knowing that our dedicated Elections staff and volunteers are working hard to ensure our elections are legal, fair, and accurate.

Shade Tree Advisory Board — TREE TIPS

Winter (the dormant season) is the best time to prune your shade trees. Call an ISA arborist (a member of the International Society of Aboriculture) and have your tree(s) professionally pruned if they are too large for you to handle.

Never allow your tree to be topped, a very harmful practice.

Replace any missing street tree with one from the Hanover Township Approved Tree List.

March through May is the perfect time to plant new trees.

Please call the Township Office if you are interested in serving on the Shade Tree Advisory Board. An interest in trees and our "urban forest" is all that is necessary.

Homestead Property Tax Exclusion!

Did you know you can save money on your property taxes through the Homestead/Farmstead Exclusion? The Taxpayer Relief Act reduces your property tax bill on your primary residence and the savings is deducted off your actual bill. Applying is simple and once you've signed up, you don't have to worry about it again as

long as you live in your home! Under the program, individuals qualify for a homestead exclusion so long as they own the property for which they are applying, they pay the taxes on it and it is their primary residence.

Please call my offices at 610-746-5090 or 717-260-6159 so my staff can guide you through the application process and submit it on your behalf. You may also visit my district office in Nazareth at 134 South Main Street if you prefer inperson assistance.

This is a one-time application and MUST be filed by March 1st. Applicants will be notified within 30 days if they qualify for a reduction in their real estate taxes.

You will then get your SEPTA Key Card in the mail.
- There are no income limits for the LANTA Senior Citizen Transit ID Card or the SEPTA Key Card.

My District Office is located at 104 E. Broad Street, Bethlehem, and is open Monday through Friday from 8:30 am to 4:30 pm. Community Utilities of Pennsylvania

Dear Members of the Westgate Community,

At Community Utilities of Pennsylvania, our most fundamental obligation — which we take seriously and conscientiously - is to provide safe and reliable water service to our customers, and we do that well. Approximately 16 hydrants are connected to that portion of the system. They are functioning as designed, arë all in service, and are utilized by operational staff for maintenance of the water distribution system during times of line breaks, cloudy water complaints, annual system flushing, etc. We have partnered with an engineering firm to evaluate the Westgate water system. A fire flow study was performed and was utilized to make improvements to the water system resulting in the addition of 4 new fire hydrants and 8 existing hydrants being upgraded to provide minimum fire flow. The study will also be utilized to direct future improvements to the system such as water main replacements.

Hanover Township Management and Hanover Township Volunteer Fire Co. #1 have been notified of these changes and know which 8 hydrants have "flushing only" collars affixed to them. The fire company is aware that these 8 hydrants are for maintenance purposes only and respond to fire calls in this section of the Westgate system with automatic dispatch to neighboring fire companies to provide additional water supply for firefighting efforts.

We will continue to work with the engineering firm utilizing the fire flow study to develop a main replacement plan to bring the mains of the remaining 8 "flushing only" hydrants up to fire suppression standards. The next phase of main replacement is scheduled for 2024.

MESSAGE FROM THE CHIEF

In 2022, the Colonial Regional Police Department responded to approximately 8,793 calls for service. Of those, 156 were thefts or attempted thefts in Hanover Township. Most were thefts



from unlocked motor vehicles which were parked outside of the owner's residence, and the majority of these thefts happened in the nighttime hours. Other theft reports were thefts of packages from porches and mailboxes. Also reported were several victims scammed by phone calls.

There are simple ways to avoid being the victim of these "crimes of opportunity". Keep your car doors locked when your car is parked in your driveway or at a store. Most thieves will bypass a vehicle when they find the doors locked. Never leave anything of value in your vehicle like laptops, purses, or wallets. Especially don't leave them in plain sight. If you're expecting a package to be delivered to your home, make sure you track it. When it's delivered, immediately have it removed. If you are not at home to remove it yourself, ask a neighbor or a family member to do it for you. Thefts of packages from porches happen at all times during the year, but the frequency increases during the holidays. As for phone scams, never provide any personal information such as social security numbers, bank account numbers, or credit card numbers to someone on any unsolicited phone call. The IRS will only contact you by mail, and no legitimate agency will ask you to pay for something or pay a fine by having you purchase any type of gift card and reading the card numbers to them over the phone. Some of the more common phone scams are the scammers calling and telling you there is a warrant out for your arrest or that a family member has been arrested and they need bail money. Another scam is that you won money and that you must pay the taxes before they can send you your winnings. Remember the adage, "if it's too good to be true, it probably is".

Keep yourself safe by taking a few easy steps. Let your family or neighbors know when you're expecting deliveries or when you are having work done on or around your property. If you are going away for an extended period, make sure your house is locked up, lights are on timers and your mail is stopped or being picked up by a friend or family member. Be aware of your surroundings. If something is suspicious or out of place in your neighborhood, it should be reported to the police by calling the Northampton County 911 Center's non-emergency number, 610-759-2200, or by simply dialing 911.

Tips to help keep safe in the cold weather.

When you are outside, frostbite and hypothermia are possible, so you need to protect yourself.

- 1. Wear layers of loose-fitting, lightweight, warm clothing.
- 2. Wear a hat. Try to stay dry and out of the wind.
- 3. Cover your mouth to protect your lungs from extreme cold.
- 4. Mittens, snug at the wrist, are better than gloves.

What are the warning signs of Hypothermia?

Sometimes it is hard to tell if a person has hypothermia. Look for clues. Is the house very cold? Is the person not dressed for cold weather? Is the person speaking slower than normal and having trouble keeping his or her balance?

Early signs of Hypothermia:

- Cold feet and hands
- ✓ Puffy or swollen face
- ✔ Pale skin
- Shivering (in some cases the person with hypothermia does not shiver)
- ✓ Slower than normal speech or slurring words
- ✓ Acting sleepy
- Being angry or confused

Later signs of Hypothermia:

- ✓ Moving slowly, trouble walking, or being clumsy
 - ✓ Stiff and jerky arm or leg movements
 - ✓ Slow heartbeat
 - ✓ Slow, shallow breathing
 - ✓ Blacking out or losing consciousness

WINTER TIPS



SHOVEL

Shovel snow onto vegetated areas. Grass and plants will act as a natural filter once snow melts, reducing runoff that goes down storm drains directly to rivers and streams.



PLAN AHEAD

Shovel and scrape early and often.
De-icers work best when there is only a thin layer to remove.



USE LESS

A little salt goes a long way. Apply sparingly and remove slush once the snow melts to prevent refreezing.



RECYCLE

Save money by reclaiming salt for reuse by sweeping or vacuuming the solids from the sidewalk or driveway after the storm.



STORAGE

Practice good housekeeping by storing salt or other de-icers under a roof or other cover to minimize polluted runoff.



VEHICLES

Winterize vehicles so that there are no leaks. Do not wash the car in the driveway – ensure that dirty washwater is not entering the storm sewer.

GOT SNOW? • GO LOW SALT!

How to Reduce the Impact of Salt in Our Watershed

Buy Early: Make sure to have your stock of deicing products already in hand well in advance of the first big storm of the season. This way you will have a better selection of environmentally friendly products.

Avoid Kitty Litter and Ashes: These products do not melt snow or ice, and when it warms up they get messy. Sand provides better traction.

<u>Shovel Early and Often:</u> Deicers are most effective when there is only a thin layer of snow or ice that needs to be melted.

Apply Salt Early, but Sparingly: After you shovel and scrape as much snow and ice as possible, throw about a handful of rock salt per square yard. For calcium chloride salt, only a handful for every three square yards is needed.

Know Your Salt-Risk Zone: Note any plants, shrubbery, or grass that is within five to ten feet of your sidewalk and driveway and avoid using deicing products that contain chloride.

Your residential Waste & Recycling bills for services for the 2023 calendar year was mailed on January 20, 2023 to each residential property owner. If you do not receive your bill by the end of January, please call the Municipal Office at 610.866.1140. Our office will accept payments during business hours Monday through Friday, by mail, or deposited in our mail slot during non-business hours.

Like the Yard Waste Calendar, the Residential Waste & Recycling was dropped off at the Post Office for Bulk Processing and Delivery on December 10, 2020. It is available on line on the Township Website.

MAILBOXES

The Township is not responsible for damage to mailboxes during snow operations. Please check your mailbox to make sure it is not overhanging the roadway. Over time, mailboxes tend to lean one way or the other and in some instances the lean is toward the roadway.

TREES

Please note that the Township when time permits trim's trees overhanging the roadway, to provide proper clearance for vehicles. If you do not want your trees trimmed by the Township, please have your trees trimmed regularly.

Property owners who live on corner properties should also be aware that you should not plant anything in the "Clear Site Triangle".

Shrubs and pine trees overhanging the road have also become a problem. Please keep all trees and shrubs behind the rear face of curb. Proper clearance for pedestrian's walking on sidewalks has also become a problem in some areas. Please remember this can be a liability to you. Clearance should be 8' above any and all walking areas. If you have low hanging branches, please trim them up.

CLEAN UP AFTER YOUR PETS RESPECT PROPERTY CLEAN UP AFTER YOUR PETS

The Township continues to receive complaints concerning dog owners not cleaning up after their dogs. Please make sure you carry bags with you and dispose of them properly.

Recently, residents have started to call because pet owners drop their dog waste in residential recycling barrels. The waste hauler dumps these bags out, leaving them for the property owner to deal with.


thanks to those who so generously donated their yummy baked goods and to those who helped during the sale.
