Mr. Prendeville offered words of remembrance by starting out that the wound is too fresh to comprehend. Mr. Prendeville is grateful to have had Vince in his life as a friend. Vince always carried himself with the grace and dignity. Vince will forever be in his thoughts.

Mr. Nagle met Vince about 17 years ago; Mr. Nagle considered Vince a friend as well as a friend to everyone in the Township. Vince was a man's man but very tender as only a man of daughters can be. Vince was always available to help. Vince's dedication to the Township was unsurpassed; he was the first

person and last person at any Township event. One of Vince's greatest assets was his leadership; he led by example; which was invaluable to the Township. Mr. Nagle will miss Vince.

Ms. Lawless will forever be influenced by the grace and strength that Vince has shown over the last four and half years. Vince's strength was only exceeded by his love for his family and community. Ms. Lawless stated it is a shock and not fair that a fighter does not get one more round. Thank you, Vince.

Mr. Finnigan stated that his former secretary summed it up best with her Facebook post yesterday. "Strength does not come from winning. Your struggles develop your strengths. When you go through hardships and decide not to surrender, that is strength." — Mahatma Gandhi

Mr. Finnigan remembered first meeting Vince. His physical strength was impressive. He was a bull there wasn't a physical activity he couldn't perform solely. Over the years, as cancer took its toll on his physical abilities, his true strengths came to the forefront. He had a heart of gold and his love for family wife, children, spouses, significant others, grandchildren, his dad, and his friends was second to none. The Hanover Township staff was truly his second family. As big as his physical presence was, he was a teddy bear. Inside that mean, tough, intimidating presence was a cream puff.... A big ass Teddy Bear. Cancer may have ravaged his physical body, but his love, care, and compassion burst through for all to see.

I could talk forever about Vince We lost a great one yesterday, and I lost a true friend and my brother from another mother. Riposa en pace
